### Terms of Consignment:

1. Consignment fee of \$200/horse. Must be paid at time of consignment. Commission: 6%.

Make checks payable to: Alvin Martin.

2. Pass out fee: \$200- however you do have the right to accept or refuse the final bid while the horse is still in the ring. If a sale is made after the horse leaves the ring the sale MUST go through the sale office.

**3. CATALOG DEADLINE IS JULY 1<sup>st</sup>. Consignments for non cataloged horses close Sept. 1<sup>st</sup>.**

4. There will be NO SUBSTITUTIONS. Horses not cataloged will sell last.

5. Horses will be sold in catalog order.

6. A signed Breeder's Certificate must accompany all bred mares and mares selling with foals at their side. Bred mares must arrive with veterinarian documentation proving the mare is checked in foal no more than 2 weeks prior to the auction date OR have the mare inspected by the veterinarian on site on sale day. Charges will apply. **STUD FEES MUST BE PAID.**

7. INDIVIDUAL AND ORIGINAL NEGATIVE COGGINS TEST WITHIN 6 MONTHS & CURRENT HEALTH CERTIFICATE WILL BE REQUIRED WITH EACH HORSE, WHICH CAN BE ACCOMPANIED WITH THE HORSE ON SALE DAY.

8. Horses sold which are unsound in eyes, wind, are "wind suckers", "cribbers", or are of known lameness must be announced.

9. Entries will be provided stalls and bedding. Bring your own feed.

10. Transport horses will be charged \$150 stall fee per stall used.

11. Extra stalls used for tack \$100. Consignors are encouraged to share tack stalls.

Withdrawing your horse from the auction requires a vet statement to avoid fees. I have completed this form to the best of my ability.
